SUBJECT: Call for a Public Hearing to Amend the 2021-2022 HUD Annual Action Plan

TO BE PLACED ON COUNCIL AGENDA OF February 7, 2022

Background Information:

This request is for the reallocation of unexpended CDBG funds in the 2021-2022 HUD Annual Action Plan Public Works category. The amount of reallocation is \$250,000, which requires a substantial amendment to the Annual Action Plan and necessitates City Council approval, a 30-day public comment period and a public hearing.

The 30-Day Public Comment Period will begin Monday February 7, 2022 and will end Wednesday, March 9, 2022.

The reallocated funds will be used for city park improvements, and may include, but is not limited to: financial support to proceed with the current plans being developed for Jerry Burrell Park that include a new splash pad area, basketball court rehabilitation, and seating improvements, and funding for a new fitness facility at Orchard Park as part of a grant award through MVP Health Care.

Recommendation:

A resolution from City Council to hold a Public Hearing in Room 209 on Monday, February 28, 2022 and to amend the 2021-2022 Annual Action Plan to include \$250,000 of unexpended CDBG Public Works funding for the use of improvements to City Parks.



An ORDINANCE amending the Chapter 264 - Zoning of the Administrative Code of the City of Schenectady changing the zoning classification of tax parcels Section 40.30, Block 2, Lot 3 and Section 40.38, Block 1, Lots 1 through 18 and Lots 22 through 24 from the "R-1" Single-Family Residential District to the "R-3" Multi-Family Residential District.

BE IT ENACTED by the Council of the City of Schenectady as follows:

Section 1: Chapter 264 - Zoning of the Administrative Code of the City of Schenectady shall be amended to change the zoning classification applicable to tax Section 40.30, Block 2, Lot 3 and Section 40.38, Block 1, Lots 1 through 18 and Lots 22 through 24 from the "R-1" Single-Family Residential District to the "R-3" Multi-Family Residential District.

Section 2: This ordinance shall take effect immediately.
